2	Form LS-10 is a mandatory form when coverage is provided by form LS-4, LS-5 or LS-6.
3-6	Additional descriptive wording is added to the basis of premiums. The descriptive wording has been expanded to provided greater clarity. Passenger Days is a new basis.
7	The standard minimum premium has been reworded to offer greater clarity. The minimum premium amounts have all remained the same. The minimum premiums shown for Business General Liability, Business General Liability-Extra Coverage, Personal Injury, Druggist Liability, Fire Damage Legal Liability have been moved to the optional coverages section of the manual under their appropriate names. There are no changes in the minimum premium amounts. Clarification notes as to the rating method for use of these minimum premiums are located at the bottom of the page.
8	Clarifying language added for the rating of CPL and OL&T exposures on the same premises. This was changed by previous bulletin and is now being placed in the manual.

- 9 Rating Rule
2. Products rating has been added to this manual rule.
 7. Deductible has been revised, to be consistent with other manuals.
 9. Is reworded to detail the proper use of the minimum premium at each location.
 10. Describes the method used to find the final location premium.

- 10 Increased Limits heading - "TORT REFORM INCLUDED" added for clarification.

It is not necessary to make a separate calculation for tort reform. The tort reform reduction is included in the increase limits factors and filed in previous bulletins.

- 11 Clarification of the rating method for Medical Payments has been added.

Provisions are made for School and Day Care Centers to use the same Medical Payments factors as Churches.

The method to calculate each additional \$500 of Medical Payments has been added.

- 12 The method to calculate each additional \$500 of Medical Payments has been added to 1 - 2 Family Dwellings.

- 13 The method to calculate each additional \$500 of Medical Payments has been added to Storekeepers Liability.

- 16-45 The following classifications have been added to premises /operations:

All five digit classification codes have been revised. The first two digits represent the price group (a group of similar classifications). The last three digits represent the specific classification. This type of coding will provide a means to gather similar classifications into the same price group to provide greater statistical validity.

Rates for the following classifications (OLT & MC) were obtained in three ways:

- 1) Rates for the largest twenty URB classification were compared to the rates from the ISO manual. The URB rates were 64% of the comparable ISO rates and therefore when an ISO classification is put in the URB manual, the rate is 64% of the rate in the ISO manual.

2) Rates for the largest twenty URB classification were compared to the rates from the AAIS manual. The URB rates were 108% of the comparable AAIS rates and therefore when an AAIS classification is put in the URB manual, the rate is 108% of the rate in the AAIS manual.

3) The URB compiled a list of all classifications from member and subscriber companies. If rates were promulgated by another company, they were put in the URB manual with no change. Any classification that did not have a known rate, was set on a judgement / experience basis.

The number designation before the classification indicates that the rate was obtained from (1) ISO, (2) AAIS or (3) industry usage or URB judgement.

Page	Description of Change
16-45	The following classifications have been revised due to errors by the URB when the manual was original written. These errors did not become evident until recently as these classification were rarely or never used. The dollars of premium written is extremely small and this correction will have almost no impact on premiums.
22-23	Building or premises - Bank - This classification is similar to building or premises - office. The rate for office is 8.80 and the rate shown for bank was 56.30. This was an error in our original filing and the correct rate for both classifications is 8.80. During the most recent year the written premium for this classification was \$1,302.
24-25	Christmas Decoration Street - This classification is based upon "per banner". This would produce a very high premium and we are revising the basis of premium to a flat charge. During the most recent year the written premium for this classification was \$ 0.
24-25	Cleaning and Dyeing receiving stations - This classification is similar to classifications for ISO and AAIS. The intent of our original filing was to have the base rate a percentage below (.64) the ISO rate. The ISO rate is 7.20 and our rate is revised to $(7.20 \times .64)$ 4.60. During the most recent year the written premium was \$ 791.
28-29	Fairs & Fairs Outside - These classifications are based upon receipts. Many times fairs are run by not for profit organizations and we believe a more equitable charge is a flat charge. During the most recent year the written premium was \$ 0.

- 34-35 Optometrists Office - This classification is similar to medical office. The rate for medical office is 15.50 and the rate shown for optometrists office is 30.80. This was an error in our original filing and the correct rate for both classifications is 15.50. During the most recent year the written premium for this classification was \$ 0.
- 42-43 Street Banners - This classification is based upon each banner. This will result in an excessive premium and we believe a more equitable charge is a flat charge. During the most recent year the written premium was \$ 61.

71 Aggregate Limits Factors are calculated in a similar manner to the aggregate limits calculation in the Businessowners Manual, previously filed and approved by the Insurance Department.

The URB has had no experience in calculating aggregate limits factors therefore we have used the same factors as those used by AAIS.

AAIS uses the following credits for aggregate limits. These credits are based upon the aggregate / occurrence multiple.

The URB used these same calculations in setting our table.

An example of these calculations is shown below.

occurrence limit 300,000
 aggregate limit 1,000,000

$$1,000,000 / 300,000 = 3.33 \text{ rounded to } 3.$$

If the Aggregate / Occurrence multiple is 3 then AAIS uses a credit of 4%.

$$100\% - 4\% = 96\%$$

The URB table shows the factor .960. When multiplying .960 by the premium will yield a 4% credit.

- 71 Assault & Battery Exclusion has been added to the manual with a rate credit.
- 72 Business General Liability has been clarified to assure rating accuracy, with no rating change.

3. GENERAL RULES:

3-a BASIS OF PREMIUM -

The basis of premium is the unit of exposure used to determine the premium. The symbol indicating the basis of premium is shown on the rate pages with the Classification and Code Number.

The following Symbols appear on the classification and rate pages. These symbols indicate the basis of premium used to calculate the premium.

For an individual or partnership, use the actual payroll (\$20,000 minimum) as the annual payroll for each individual insured or each co-partner.

For a corporation, use the actual payroll (\$20,000 minimum) as the annual payroll for each active executive officer.

In addition to the above, charge for the entire payment by the insured for services of employees, whether paid in money or a substitute for money. Rates apply per \$100 of payroll, with a minimum payroll of \$20,000.

Payroll INCLUDES the following:

- a) Commissions and bonuses.
- b) Pay for holidays, vacations or periods of sickness.
- c) Payment by an employer of amounts otherwise required by law to be paid by employees to statutory insurance or pension plans.
- d) Payment to employees on any basis other than time worked.
- e) Payment or allowance for hand or power tools furnished by employees.
- f) The value of board and lodging provided to employees.
- g) The value of store certificates, merchandise, credits or any other substitute for money received by employees as part of their pay.

Payroll EXCLUDES the following:

- b) Payments by an employer to group insurance or group pension plans for employees, other than those mentioned in (c) above.
- c) The value of special rewards for invention or discovery.
- d) Dismissal or severance payments except for time worked or accrued vacation.

e) Extra pay for overtime.

Overtime means those hours worked for which there is an increase in the rate of pay for work (i) in any day or week in excess of the number of hours normally worked, (ii) in excess of eight hours in any day or 40 hours in any week, or (iii) on Saturdays, Sundays or Holidays.

If the insured's records show the total pay earned for overtime (regular pay plus extra pay) in one combined amount, extra pay is computed as 1/3 of the total overtime pay if time-and-one-half is paid, or 1/2 of the total overtime pay if double time is paid. Exclusion of extra pay for overtime does not apply to payroll assigned to stevedoring operations.

It is permissible to attach any filed form offering supplemental coverage not included in this section. The appropriate rates are to be used.

3-d MAXIMUM & MINIMUM CHARGES

3. Obtain Bodily Injury Factor (Note: includes \$5,000 Property Damage) (single limit includes BI & PD).
4. Adjust Bodily Injury factor (add or subtract) for appropriate Property Damage limit (except single limit).
5. Multiply total of combined Bodily Injury and Property Damage Limits factors (or single limits factor) by the base rate to obtain adjusted rate.
6. Multiply adjusted rate by amount of exposure to obtain premium.
7. Apply any deductible. (Note: Deductible does not reduce Minimum Premium.)
8. Round each classification separately and combine premiums for each location.
9. Use the greater of the standard minimum premium or any classification minimum premium at each location. Multiply this minimum by the increased limits factor. (See notes under minimum premium section).
10. The final location premium is the greater of step 8 or step 9.
